A final chapter explains legal citation, with information on the California Style Manual, the ALWD Citation Manual, and the Bluebook. Print and online resources are introduced simultaneously, with guidance on when each medium is likely to be most effective in solving legal problems. Outlines of the research process and focused excerpts from key state sources make the book easy to use. Brief discussions of legal analysis are included throughout, recognizing the interplay between research and analysis. California Legal Research supplements its primary discussion of state research with brief discussions of federal research. Thus, it can be used as the sole text in a research course or in conjunction with texts focusing on topical or federal research.
